AFTER A FULL REQUEST FOR PROPOSAL, UAC AND LIFESOUTH ENTERED INTO A FIVE-YEAR AGREEMENT FOR MANAGEMENT SERVICES OF LIFESOUTH'S CARGO PLANE ON MARCH 14TH, 2018. ALL AGREEMENTS AND CONTRACT TRANSACTIONS BETWEEN UAC AND LIFESOUTH WERE AND HAVE PREVIOUSLY BEEN VOTED ON BY THE FULL BOARD OF DIRECTORS. DR. LUKOWSKI ABSTAINED FROM ALL RELATED VOTES. THE BOARD OF DIRECTORS REVIEWS THE MANAGEMENT SERVICES AGREEMENT ON AN ANNUAL BASIS, AS A MEANS OF DISCLOSING CONFLICTS OF INTEREST.
