FIFTY YEARS OF SAVING LIVES

This year, LifeSouth is honored to celebrate the remarkable milestone of 50 years serving our communities with our staff, donors and hospitals. For five decades, our operations have grown from a single small community blood center serving a few local hospitals in Gainesville, Fla. to the robust organization you know today, helping patients at over 150 hospitals across five states in ways we never could have imagined when we began.

LifeSouth was built on a solid foundation of service and community, founded in 1974 by a group of community leaders who believed wholeheartedly in our lifesaving mission. It has continued to grow and thrive thanks to our dedicated team members, strong hospital partnerships and goodwill of the communities we serve.

We kicked off our 50th anniversary celebration with a ribbon cutting for the renovated donor room at our corporate headquarters building in Gainesville, Fla. This was a year of continued growth as we expanded our services and operational footprint, becoming the local blood center for several communities, with new donor centers in Pelham, Ala., Harvest, Ala., Tifton, Ga. and Ocala, Fla. and establishing new regions in Columbus, Ga., St. Augustine, Fla. and Tampa, Fla. LifeSouth's Citrus region celebrated its 40th anniversary and renovations were completed on the Northeast Georgia region in Gainesville, Ga., providing an updated space for donors and staff.

This year also saw an increase in advocacy for treatment using pre-hospital blood transfusions administered during emergency rescue and transport. Blood provided to patients as quickly as possible following trauma can save lives. LifeSouth is proud to provide blood for ambulatory medical services in eight locations. In 2024, we began supplying blood for fire and rescue EMS in The Villages, Fla., St. Augustine Fla., Oxford, Ala. and Tuscaloosa, Ala.

The LifeSouth Research Institute began collecting mononuclear cells for medical research, including for lupus and other autoimmune disorders. We also partnered with a large pharmaceutical company to process a genetically modified autologous immunotherapy for the treatment of patients throughout the Southeastern US suffering from multiple myeloma.

This year, we recognize the commitment and advocacy of Reeves Byrd, who retired from the board of directors after 50 years of lifesaving service. In 1974, Reeves helped found the Civitan Regional Blood Center as one of our "Founding Fathers," and served as our first president. We also recognize Avis Marie Craig, who retires this year after serving on LifeSouth's board of directors for 19 years. We thank both Reeves and Avis for their years of dedication to our mission and for helping shape our organization into what it is today.

Looking back over our first 50 years, LifeSouth has grown and changed exponentially, along with the blood banking industry and the needs of the hospitals we serve, but our mission remains the same today as it was when our organization began: to ensure that our hospitals have a safe and plentiful supply of blood to treat the patients who need it. In 1974, in Gainesville, Fla., Reeves Byrd and several members of the Civitan Club of Gainesville helped found the Civitan Regional Blood Center, now LifeSouth Community Blood Centers, and served as its first president. For almost fifty years, he served on the Board of Directors as the Vice-Chairman. Reeves served on the Nominating, Finance and Audit and Executive Committees.



PAST

For 50 years, LifeSouth has grown at the request of hospitals in need of a dedicated community blood supplier.

In 1974, hospitals were in critical need of volunteer blood donors after the FDA curtailed the practice of paying donors for blood donations. Gainesville, Fla. hospitals (Alachua General Hospital, UF Health Shands Hospital and Malcom Randall VA Medical Center) all agreed that a non-profit community blood center was the answer and made an appeal to all local civic organizations. The Gainesville Civitan Club was the only organization that agreed to take on this task. Members backed a loan with their own money to start what they called Civitan Regional Blood Center - today known as LifeSouth Community Blood Centers.



At the request of local hospitals, the 1980s brought expansion through North Central Florida in the Lake City, Palatka, Crystal River, Brooksville and Ocala communities. In 1994, LifeSouth began serving Alabama with our first center in Birmingham, followed by Atlanta, Ga. in 1995. Significant growth continued in Alabama, with LifeSouth opening districts in Montgomery in 1997, Huntsville in 2002 and Mobile in 2007. In 2018, LifeSouth opened its newest district in Jacksonville, Fla.

50 years later, LifeSouth has over 1,000 employees and operates in 51 locations with 68 bloodmobiles, two planes and is a proud partner of over 150 hospitals in Florida, Alabama, Georgia, Mississippi and Tennessee.


CELEBRATING AVIS MARIE CRAIG'S DEDICATED SERVICE
























PRESENT

In 2023, LifeSouth celebrated 20 years of saving lives at Dragon Con, a multimedia pop culture convention held over labor day weekend in Atlanta, Ga. and our largest blood drive of the year. The drive collected our fifty-thousandth Dragon Con blood donor.

The Northeast Georgia region opened in 1997, and in September 2023, LifeSouth welcomed donors to the newly renovated Gainesville, Ga. facility. After nearly thirty years, the region received a refresh to enhance the experience for donors and operational efficiencies for staff.

On October 1, LifeSouth donors who opted into text messages began receiving notifications when the blood they donated was shipped to a hospital, letting them know that their blood was on its way to save a life. Since then, more than 119,023 notifications have been sent to donors. The messages also serve as a reminder of the importance of their lifesaving gift, prompting more than 77,842 recipients to return for their next blood donation appointment.

In November 2023, LifeSouth's Citrus region celebrated its 40th anniversary in Lecanto, Fla. with a ribbon cutting to showcase a newly renovated donor center. The region opened in 1983, when hospitals in Citrus County asked LifeSouth to supply blood for their patients. Board of Directors member and Citrus County resident Avis Craig spoke to the crowd, which included staff and many longtime blood donors from the community.

LifeSouth kicked off its 50th anniversary with a ribbon cutting ceremony at its corporate headquarters building in Gainesville, Fla. in March 2024. The event showcased an updated donor center and new space dedicated to research donations. We have commemorated our 50th anniversary throughout the year with gifts for donors and employees as well as a birthday celebration on May 30 in honor of "Founders Day," the day LifeSouth was founded with the state of Florida in 1974.

LifeSouth is a part of more than 20 community blood centers in the Blood Emergency Readiness Corps or BERC. This program allows community blood centers like LifeSouth to assist in times of crisis by providing blood. In May 2024, LifeSouth was called upon to provide blood to Dallas, Tx. to treat patients injured by tornadoes, marking the first time we have been activated for a national emergency since joining BERC in 2022.



PRESENT

In the last year, LifeSouth expanded its operational footprint, opening new donor centers in Harvest, Ala., Pelham, Ala., Ocala, Fla. and Tifton, Ga., providing convenient locations for donors to save lives. We also upgraded to new donor center locations in Cullman, Ala. and Alpharetta, Ga. New regions were formed in Columbus, Ga., St. Augustine, Fla. and Tampa, Fla.

This year, LifeSouth began supplying pre-hospital blood for transfusions on ambulances to four new EMS services: City of Oxford Healthcare Authority in Oxford, Ala., St. John's County EMS in St. Augustine, Fla., The Villages Public Safety Department in The Villages, Fla. and Tuscaloosa Fire and Rescue in Tuscaloosa. Ala.

This past year, LifeSouth began serving several new hospitals, including Southeast Georgia Health System in Brunswick, Ga. in April 2024 and its Camden Campus in St. Mary's, Ga. in July 2024. Also in July, we began providing Wellstar Cobb Medical Center in Austell, Ga. In July 2023, we began providing Moffitt McKinley Hospital in Tampa, Fla.

A new addition to LifeSouth's fleet is helping donors make giving blood part of their daily life. Mobile donation centers (MDCs) are trailers renovated into a beautiful donor room. MDCs are used for long-term blood drives and can be parked for several weeks at a time, providing convenient locations for blood donation, offering comfort for donors and staff and providing a more environmentally friendly solution along with fuel cost savings.

In November 2023, LifeSouth implemented a new 403(b) retirement plan program through Voya Financial to help employees grow their retirement savings. New hires are auto-enrolled in the program, which directs 3% of each paycheck into a pre-tax retirement account, increasing by 1% each year until a 15% deduction is reached. Staff may choose to opt out or make changes to their plan. In 2024, the new 403(b) plan has resulted in over \$1.3 million in employee contributions to their retirement savings.

This year, LifeSouth implemented HemoFlow mixing scale technology in most Florida and Georgia locations, which allows for optimization of whole blood donations by targeting the optimal volume for each donor. The HemoFlow ensures proper mixture of the blood and anticoagulant, with a visual display to allow staff to monitor collection and audio alerts to signify when targeting volume is met.

In fiscal year 2024, LifeSouth increased blood collections by 1% and provided 8% more blood components than the previous year. LifeSouth therapeutic apheresis procedures increased by 8.5% and laboratory services revenues increased by 11% over the previous fiscal year.



















FUTURE

In an emergency rescue, a whole blood transfusion en route to the hospital could mean the difference between life and death. Studies have shown that transfusion of blood products before arriving at the hospital significantly improves patient survival. Pre-hospital blood has long been deployed by the military to successfully treat injuries and trauma in the battlefield. However, most locations in the US do not have access to pre-hospital blood transfusions.

In 2014, LifeSouth began serving life flight helicopters throughout the Southeastern United States and today we service 33 flight facilities in Tennessee, South Carolina, Alabama, Georgia and Florida. In 2022, we began providing ambulances with blood. Today, LifeSouth partners with eight EMS ambulance providers as part of a growing initiative to make prehospital transfusions available for patients nationwide. These emergency vehicles stock type O red blood cells and plasma to treat many injuries and conditions while patients are transported, greatly improving the chance of patient survival.

As advocacy and implementation of pre-hospital blood increases, LifeSouth continues to get requests for service from our communities' EMS programs. LifeSouth will continue to grow this program, allowing us to ensure lifesaving blood products for our EMS partners and the communities we serve.

In March 2024, LifeSouth made the decision to transition away from our homegrown Blood Establishment Computer System (BECS) called IBBIS to a third-party platform called ForLife™ by Blood Bank Computer Systems (BBCS). The BECS is an important factor in maintaining the safety and quality of the blood supply and is considered a medical device by the Food and Drug Administration because it touches all aspects of the blood donation process from donor eligibility and collections to manufacturing, testing and distribution. Complete implementation of the new software is expected to take approximately two years.

Renovations on LifeSouth's headquarters in Gainesville, Fla. that began in October 2023 will be completed in late 2024 or early 2025. The remodeled facility includes renovated space expanding cellular therapy services, a new building that includes four clean rooms, a warehouse and storage for cryopreserved cellular therapies. The newly renovated space will also provide dedicated space for our Medical Technologist training program and a research and development laboratory. A second new building will also be finished which will accommodate the components laboratory and hospital services departments, currently located at LifeSouth's 13th Street Gainesville building. Bringing components and manufacturing under the same roof as our reference and quality laboratories will improve efficiencies, reduce turnaround times and provide a more collaborative environment for our technical, quality and medical staff.

On October 1, LifeSouth will officially open a new immunohematology laboratory in Birmingham, Ala. The space was built out last year as a part of the larger renovation project at our district facility. Over the years, we've had many Alabama hospitals request these specialized patient services closer to their facilities to improve turnaround times and patient care. We're excited to provide much-needed patient services to the surrounding areas.

FUTURE


During fiscal year 2025, LifeSouth will begin providing blood products and services for several Wellstar facilities in the Greater Atlanta area. LifeSouth originally came to Atlanta in 1995 because of our partnership with the Atlanta Medical Center, eventually a part of the Wellstar Health System. Today, we provide five Wellstar facilities including Cobb Medical Center, which we began providing in July 2024. We will provide three additional facilities including: Douglas Medical Center, Paulding Medical Center, and Kennestone Medical Center before the end of the fiscal year.

Our growth in the Greater Atlanta area will be significant this fiscal year as LifeSouth is expected to begin providing blood for the Children's Healthcare of Atlanta's new facility, the Arthur M. Blank Hospital, in September 2024. Because of the significant growth expected in Georgia over the next year, we've begun due diligence on needed enhancements and operational expansion of our Atlanta location in Dunwoody, Ga.

In 2022, we celebrated our 35th anniversary serving Hernando County, Fla. After over 35 years, our Brooksville, Fla. facility will undergo much-needed renovations to upgrade the donor experience, improve efficiency and update infrastructure, including the parking lot and septic system. During the renovation, LifeSouth will relocate the donor room to a nearby facility to maintain donor collections. The renovated facility is expected to open in the spring of 2025.

In early 2025, LifeSouth Cord Blood Bank will begin cord blood collections at Jackson Health System in Miami, Fla. During the pandemic, collections at the facility ceased, and we're excited to continue our successful partnership collecting cord blood for our public bank with the hospital system.

LifeSouth and Baptist MD Anderson Cancer Center in Jacksonville, Fla. are partnering to provide stem cell therapy to patients. LifeSouth will process and cryopreserve peripheral stem cells from patients and donors to be used by Baptist MD Anderson for innovative and lifesaving therapies. Both parties will work together for accreditation from the Foundation for the Accreditation of Cellular Therapy (FACT) to ensure the highest quality and safety for the therapies. We expect to begin work on this exciting partnership in late 2024.




















LIFESOUTH RESEARCH INSTITUTE

Many willing donors are unable to give blood for transfusion due to previous deferrals, health and travel histories, medications and more. The LifeSouth Research Institute (LSRI) was created to allow these donors to save lives by participating in medical research focused on discovering lifesaving treatments for patients with cancer, autoimmune disorders and other chronic diseases rather than direct patient transfusion.

In 2024, the LifeSouth Research Institute began collecting leukopaks or mononuclear cells. These white blood cells and other blood components are donated via a process called leukapheresis, which is similar to a typical platelet donation. Some donors are contributing to specific disease research, as we collect from donors diagnosed with autoimmune disorders such as lupus, rheumatoid arthritis and Crohn's disease. We send these products to researchers affiliated with several of our academic and research hospitals.

The LifeSouth Research Institute partnered with All of Us, a research program supported by the National Institute of Health to build a diverse national database that can inform thousands of studies on a variety of health conditions rather than a specific targeted study of a smaller number of participants. The goal is to enroll one million participants who reflect the diversity of the US and to drive discoveries that will improve overall health.

LABORATORIES

Treating patients with cancer, sickle cell disease and blood disorders requires regular transfusions of antigen-matched blood. LifeSouth's immunohematology reference laboratories (IRLs) find donor matches for these special antigen patients. LifeSouth's IRLs test for 36 antigens and send an average of 24,000 special antigen units a year to hospitals in Florida, Georgia, Alabama, Mississippi and Tennessee. This year, LifeSouth also expanded HLA typing service and now performs sample testing for five other blood centers.

LifeSouth's immunohematology reference laboratories (IRLs) continue to grow. Since fiscal year 2020, revenue from LifeSouth's IRLs have increased over 70%. This growth is a result of an increase in the number of hospitals we provide but also an investment in our laboratories' technical capabilities and expertise. In 2020, we added molecular testing capabilities and in 2023 we became one of eight AABB-accredited molecular testing laboratories in the world.

Since FY 2020, our molecular testing (phenotyping) revenue has increased 1,254%. We've also seen a significant rise in HLA typing, with a 329% increase over that same timeframe. Since 2020, we have experienced an increase in revenue of nearly 500% from outside testing for other blood centers and additional third parties. This growth demonstrates the value of our investment in LifeSouth's capabilities and expertise, which are now relied upon by other blood centers across the nation.

LifeSouth continues developing laboratory scientists for the future with its investment in our Medical Technologist Training Program and Specialist in Blood Banking program.

CELLULAR THERAPIES

In January 2024, LifeSouth partnered with a pharmaceutical company to help produce a groundbreaking new treatment for multiple myeloma, a cancer affecting cells in the bone marrow. LifeSouth cryopreserves cells donated via hematopoietic progenitor cell apheresis, a procedure that collects stem cells from the patient. The cryopreserved cells are then delivered to the pharmaceutical company where they undergo further manufacturing to be used for patient infusion. The resulting product is a chimeric antigen receptor T-cell (CAR-T) therapy. As of August 2024, 173 patient samples have been processed and cryopreserved.

In February 2024, cellular therapies expanded into a newly renovated space that was previously a large conference room. Cellular therapies gained new processing facilities, administrative space and a product and supply management room.

LIFESOUTH CORD BLOOD BANK

A transplant of stem cells, which remain in the umbilical cord and placenta after a baby is born, can treat diseases like leukemia and sickle cell disease. LifeSouth collects cord blood from 18 hospitals across our footprint, placing eligible units on a public, international registry. In fiscal year 2024, LifeSouth placed 296 units on the cord blood registry and shipped nine units for transplant. To date, LifeSouth has shipped 303 cord blood units for transplant worldwide.

Cord blood units can also serve as a source material for manufacturing emerging cell and gene therapies. The field, although early in development, holds tremendous promise for the treatment of many diseases. In 2024, LifeSouth joined the NMDP BioTherapies Cord Blood Bank Alliance (CBBA). The CBBA is a partnership with nine public cord blood banks working together to make cord blood units available for this purpose. The ability to identify and supply these units leverages the more than 200,000 cord blood units in the CBBA inventory, allowing NMDP Biotherapies to rapidly locate and access cells that meet their specific requirements, helping advance medical science and improving outcomes for patients.

In November 2023, LifeSouth's cellular therapies department went live with a biotherapies laboratory management system that helps collect, process, label and track cord blood units. The move from paper to a cloud-based system will allow the cellular therapies program to grow efficiently to meet the biotherapy needs of patients and researchers while improving the safety and quality of the clinical cord blood units and other research products we provide.









THE LASTING IMPACT OF DONATION: LifeSouth Patient Story Updates

Elena Howard was diagnosed with leukemia when she was only two. When chemotherapy complications left her fighting for her life in the pediatric ICU, Elena relied on blood transfusions to survive. She received over thirty blood product transfusions during her leukemia treatment, including packed red blood cells, platelets, fresh frozen plasma and IVIG. "Those transfusions saved her life so she could survive the harsh side effects of chemotherapy. I remain forever grateful to blood donors. They are absolute heroes," said Elena's mom Haley.

Elena finished her chemotherapy in May 2024 and got to 'ring the bell' celebrating the end of her 855 days of cancer treatment.

Today, Elena is four years old and started pre-K this fall, for her first ever school experience. "I'm so glad she gets to interact with other children her age now, after spending so much time isolated," said Haley. "She has been feeling great and enjoying life to the fullest. She plays with boundless energy, which is the most beautiful sight. She loves to swim and play outside. My heart overflows with gratitude watching her experience the joy of childhood!"





Elijah Cook has sickle cell disease, which causes crescent moon-shaped red blood cells. These cells block blood vessels, causing swelling and severe pain in an event known as a sickle cell crisis.

Elijah's mom, Shareika, said he's been in the hospital more than 20 times and has received multiple blood transfusions to fight the effects of the disease. "Once you get it [blood transfusion], it's life-changing," she said. "He'll go from zero to 100 in minutes. It's a huge difference."

Shareika said Elijah, now 13 years old and in seventh grade, is thriving since beginning apheresis therapy three years ago. Prior to that, he made frequent trips to the hospital and required many transfusions. "After his transfusions, he's like a different person - more energetic and clear-headed. He's also not complaining of pain as much, and we're able to manage it at home," said Shareika. Elijah loves playing video games and playing and watching soccer. He's excited about the upcoming World Cup.

Shareika wishes more people understood the impact of donating blood. "It has truly transformed Elijah's life," she said. "He went from constant pain and frequent hospital visits to only needing to go for his transfusions. Blood donations have given my baby a life he wouldn't have had without donors like you. We are forever grateful."


When Devon was about to enter middle school, she was diagnosed with leukemia. Chemotherapy allowed her to go into remission, but in her sophomore year of high school, the leukemia returned. Devon's doctors said she needed a marrow transplant. As an African-American, she faced uphill odds of finding a match. A shared ethnic or racial background increase the chances that a donor and recipient will match, but there is a scarcity of minorities who have volunteered to be on the National Marrow Donor Program (NMDP) registry.

Fortunately, she had another option available: cord blood can be used as an alternative to a marrow transplant. Devon received a cord blood transplant that allowed her to become cancer-free and graduate high

school and college. It enabled her to acheive her dream of attending law school and becoming

an attorney. She has been able to spend many happy, healthy years with her loved ones and got married in 2022.

Devon will always be thankful for the anonymous cord blood donor who saved her life. "I would love to have the opportunity to thank the mother and child who donated cord blood," she said.



Last May, on the way to a checkup with his doctor at Children's Hospital of Alabama, he went into cardiac arrest. His mom Madyson performed CPR until he was transported by AirEvac to Birmingham. After seven months in the hospital, a second heart surgery and numerous blood and platelet transfusions, Corder was well enough to return home.

Corder continues to see his doctors and will soon undergo the last of three heart surgeries, which will allow him to reach his teenage years before he receives a heart transplant. Thanks to blood donors, Corder is able to enjoy playing with his family and has just started preschool.

He loves police officers: for his third birthday party,

he took an invitation to the Athens, Ala. police department, who showed up in three cars

with sirens to celebrate with him. He had a great time playing in the police cars and pressing all the buttons. Corder also now has a little brother, James, who is 20 months old, and they spend hours playing toy cars together. His family is grateful for the blood donors who made his recovery possible.





(in 000s)


